ต้นเรื่อง

สถานเอกอัครราชทูตอิสราเอลประจำประเทศไทย แจ้งให้กรมส่งเสริมสหกรณ์ทราบว่า ศูนย์ความร่วมมือระหว่างประเทศมาชาฟ (MASHAV) ประสงค์มอบทุนฝึกอบรมหลักสูตรนานาชาติ ณ รัฐอิสราเอล จำนวน ๓ หลักสูตร แก่เจ้าหน้าที่กรมส่งเสริมสหกรณ์ ในการนี้ สถานเอกอัครราชทูตอิสราเอล ประจำประเทศไทย ขอให้กรมส่งเสริมสหกรณ์พิจารณาผู้ที่มีคุณสมบัติเหมาะสมสมัครเข้ารับทุนดังกล่าว ภายในวันที่ ๘ สิงหาคม ๒๕๖๑

ข้อเท็จจริง

๑. ศูนย์ความร่วมมือระหว่างประเทศมาชาฟ (MASHAV) เป็นโครงการพัฒนาความร่วมมือ ระหว่างประเทศของอิสราเอล มีวัตถุประสงค์เพื่อแบ่งปันความรู้ความชำนาญและเทคโนโลยีให้แก่ประเทศ กำลังพัฒนาทั่วโลก และมีเป้าหมายที่จะส่งเสริมการพัฒนาแบบยั่งยืนและความเท่าเทียมกันในสังคม ศูนย์ความร่วมมือระหว่างประเทศสังกัดกระทรวงการต่างประเทศอิสราเอล ซึ่งได้จัดการอบรมทั้งในอิสราเอล และต่างประเทศแก่ผู้เข้าร่วมโครงการกว่า ๒๐๐,๐๐๐ คน จากประเทศต่าง ๆ รวม ๑๔๐ ประเทศ นอกจากนี้ MASHAV ยังได้นำโครงการสาธิตไปปฏิบัติทั่วโลกอีกหลายโครงการในสาขาที่อิสราเอลเชี่ยวชาญ

About the Course

Background

MASHAV is the Hebrew acronym for the Israel's Agency for International Development Cooperation, a department established 50 years ago in Israel's Ministry of Foreign Affairs. MASHAV is responsible for designing and implementing Israel's international development programs, carried out in Israel and in developing partner countries.

In cooperation with the Hebrew University of Jerusalem's Robert H. Smith Faculty of Agriculture – MASHAV's only academic professional affiliate in agriculture – we are pleased to announce the opening of a training and capacity building program entitled Agricultural and Natural Resource Economics – Changes in the Era Of Globalization. The course will be held in Israel at the Robert H. Smith Faculty of Agriculture, Food and Environment, The International School of Agricultural Sciences in Rehovot, from November 4 –23, 2018.

Agriculture is still the single most important economic sector and source of employment in emerging markets. Seventy percent of the world's poor live in rural areas. In the next decades, Many of the world's poorest regions could suffer food shortage and insufficient natural resources essential for economical growth and development.

Climate change and sustainable environment call for more sophisticated and efficient agricultural technology as the world population grows and the amount of arable land decreases. According to the Environmental Protection Agency (EPA), farmers will have to deal with "increased potential" for extreme events like droughts, floods and heat waves," and "enduring changes in climate, water supply and soil moisture could make it less feasible to continue crop production in certain regions." More mouths to feed, plus less arable land and changing rainfall patterns, mean a growing need to develop methods of production from alternative resources and technological solutions that can increase productivity. In other words, there is a growing demand for more agri-green solutions that will allow farmers to do more with less while minimizing the negative effect on the environment.

Aims

The aim of this course is to provide decision making tools that will enable the participants to confront the present and expected challenges in the agricultural sector, and to make decisions regarding management of natural resources used for sustainable agricultural production. These tools will also help deal with global financial changes, including international trade agreements and terms of trade; greenhouse gas emission reduction, environmental changes, changing rainfall patterns etc.

Israel has extraordinary experience and "know-how" in confronting these challenges, particularly when dealing with the agriculture-water-environment relationship. The course addresses these issues with a multi-disciplinary decision-making approach while focusing on the agri-environmental considerations needed under climatic changes.

The course suggests concepts methodologies and information that can be later adapted and implemented by the participant when confronting challenges in their own countries. In addition, the course promotes networking and research cooperation among the participants and the Israeli experts.

Main Subjects

The MASHAV program Agricultural and Natural Resource Economics – Changes in the Era Of Globalization offers a unique learning opportunity for mid-career practitioners and decision-makers to broaden their knowledge and perspectives on agricultural and natural resource science, policy and management. Through exposure to innovative sustainability approaches, field tours and dialogues, participants will develop the tools and skills necessary to confront global changing environments and increase food security and economic stability.

Workshop topics will be:

- Population, Health, Wealth and the Environment: Understanding global changes and
 regional demographic dynamics and conceptual frameworks linking population, health,
 poverty/wealth and the environment. Learning successful community-based approaches for
 integrating population issues with natural resource management and promotion of sustainable
 livelihoods.
- 2. Policies for sustainable development: Understanding the principles of environmental policy-making and trade-off analysis with respect to land use, food, fuel and biodiversity. Learning to identify different economic instruments, including life-cycle analysis, policy options and market strategies for solving complex environmental problems such as climate change, degradation of ecosystem services, and renewable and non-renewable resource scarcity. Learning methods to assess demand for environmental amenities and develop strategies to implement change.
- Resources and Sustainable Agricultural Management: Discussing current technologies and
 policy approaches that jointly promote sustainable agriculture and conserve natural resources,
 including agricultural production technologies, drip irrigation technologies, sludge management,
 land cultivation practices, eco-agriculture, and GIS tools for community-based resource
 monitoring.
- 4. Impact Assessment and Quantitative Analysis: Introduction of methods to evaluate and compare the impact of environmental, agronomic, and economic policies. Learning how to design experiments to quantify the impacts of policy interventions and how to look for and use available data to assess effectiveness of natural resources and agronomic development.
- Mitigation and Adaptation to Climate Change: The workshop will cover three major issues:
 Working Landscapes and Biodiversity Conservation;
 Climate Change Science, Mitigation & Adaptation;
 Water Governance, Monitoring & Management.

Application

Application Requirements

Course completion

Each participant will prepare a seminar presentation, which will be reviewed and graded. It should apply knowledge acquired during the course to a topic in Agricultural and Natural Resource Economics. Participants are advised to bring with them digitalized data relevant to their countries. On completion of the course and fulfillment of its requirements, participants will receive certificates.

Requirements

Candidates interested in attending this program require:

- An academic degree (M.Sc. or above) in economics, environmental sciences, Agriculture or development studies from a recognized university. (A copy of the degree must be included with the application form).
- An authorized certificate of high level English proficiency or a certificate proving that English was the language of study.
- A detailed record of studies must be included with application forms.
- A statement of good health signed by the applicant.
- Two letters of recommendation from the candidate's place of work or study.

Cost and application

Scholarships are available from MASHAV (see below) to cover the fee for study. The scholarship covers tuition, board, lodging, health insurance and travel in Israel required for the purposes of the program of studies. This fee does not include travel costs to and from the home countries or incidental expenses.

Health
